Learning Objectives

- The Authorization Agreement for Automatic Deposits or EFT Forms must be completed by each Agency for any payments after their first payment.
- All newly funded agencies participating in EFSP for the first time, are issued their first payment by check. If the agency received funds in a previous spending cycle, they are not considered new.
- If an agency receives funding in multiple jurisdictions, they will need to enroll for automatic deposits in each jurisdiction separately.
- If an agency decides to use a different bank account to receive funds from EFSP or their bank's routing number changes, they must submit a new form for automatic deposits, along with an original voided check, to prevent delays in the receipt of funds.

EFSP

The Emergency Food and Shelter Program was established on March 24, 1983, with the signing of the "Jobs Stimulus Bill," Public Law 98-8. That legislation created a National Board, chaired by the Federal Emergency Management Agency (FEMA) that consisted of representatives of the American Red Cross, Catholic Charities USA, The Jewish Federations of North America, National Council of the Churches of Christ in the USA, The Salvation Army and United Way Worldwide.

The EFSP was authorized under the Stewart B. McKinney Homeless Assistance Act (P.L. 100-77 signed into law on July 24, 1987, since renamed the McKinney-Vento Homeless Assistance Act and subsequently reauthorized under P.L. 100-628, signed into law on November 7, 1988). Since 1983, in its 36-year history, the EFSP will have distributed \$4.5 billion to over 14,000 human service agencies in more than 2,500 communities across the country through this collaborative effort between the private and public sectors...More







- The preprinted form can only be used for the agency noted in that specific jurisdiction. If an agency is funded in multiple jurisdictions, they will need to complete EFT forms for each to receive the funds.
- The completed form and an original voided check must be mailed to the National Board.
